PRODUCT DESCRIPTION

Epifanes Woodfinish Matte is a fast drying, scratch resistant one component varnish based on urethane alkyd resins. This varnish gives a beautiful matte finish. It gives great protection against alcohol and other household chemicals. It can be used in an interior system or an exterior system.

Field of use: As a matte final coat in a new system or as a maintenance varnish in an existing system. It can be applied on basically every varnish. For bare wood we always recommend to start with build up coats of high gloss varnish with UV filter. This is to protect the wood from the inside of the grain.

The above mentioned drying times are indicative at 65% RAH and 30 µm dry filmthickness. Drying also depends on ventilation and applied wet filmthickness. Higher wet filmthickness and/or poor ventilation will result in longer drying times. Especially horizontal parts may take longer to dry due to high wet filmthickness. Allow each varnish coat sufficient time to dry. Do not apply wet-on-wet.

Substrate New system: Clean the previously applied high gloss varnish. Sand the coat with P240. Apply

the Epifanes Woodfinish Matte in 2 coats.

Existing system: Clean the varnish and sand it with P240. Apply 2 coats of Woodfinish Matte where the 1st coat is lightly thinned to get in to the sanding scratches of the old varnish.

APPLICATION

Conditions during application Temperature Relative air humidity minimal 8°C. - maximal 30°C. minimal 50% - maximal 85%

Best results are archieved by using a longhaired soft brush or by air spray. Because of the required wetfilmthickness application by roller is not advised. Evenly distribute the varnish over the surface and tip off along the wood grain. Avoid retipping. Do not apply wet-on-wet. Do not apply excessive wet films to avoid the formation of curtains and drying problems. Avoid varnishing in direct sunlight or much wind. A rapid loss of solvents will occur under these circumstances and this will decrease the flow. Avoid large difference in temperature of the product, surface to be varnish and working area. In case the product "pulls" and is difficult to apply, 10% thinner may be added. To retrieve the original colour of the wood, up to 10% Epifanes Mahogany Stain or Epifanes Teak Stain may be added to the varnish. After drying, lightly sand the surface with P400 or Scotch Brite. Always sand by hand along the wood grain.
