## **PRODUCT DESCRIPTION**

Impregnating oil for maintenance and protection of teak and any other wood type. There will be no build-up when using this sealer. All product will impregnate fully into the wood. It makes the natural colour of the wood stronger and protects it for a longer period of time against discoloration and moisture coming in to the wood. The application of the product is extremely easy and can be done during almost all weather types.

Field of use: For the maintenance and protection of decks or teak objects that need protection and that won't be varnished. Do not use for furniture, while the oil can be sticky and can leave marks on to clothes when it is freshly applied.

### APPLICATION

Apply the oil wet-on-wet and repeat this treatment until the wood is saturated with oil. The number of coats depends on the remaining concentration of oil and the suction power in the wood. On average two coats will be sufficient. Use a brush or a lint free cloth for application. Do not use a roller, while this won't distribute the sealer well.

| Important             | This sealer has an effect on the rubber compounds in a teak deck system. The Teak-Oil-Sealer can activate the plastisizer in the sealant. This will create a situation where the sealent will become softer and loses its power to seal of the surface.   |
