PRICING

All our prices are in EURO (€) inclusive 19% (7% for books) German VAT (Value Added Tax: "Mehrwertsteuer"), but exclusive costs for postage or carriage.

In general, the German VAT will be charged for all EEC orders. EEC customers registered for VAT, please state your valid VAT identification number: VAT Reg.No., P.IVA, MomsNr., N.I.F., No.TVA, SE-Nr., ALV-NRO, OB-Nummer. Those registered customers or customers from outside EEC can receive goods without VAT being charged. Please divide the stated (catalogue) prices by 1.19 as this is the VAT free export price!

While great care has been taken in compiling this shop, we must stress however, that errors or omissions are unavoidable. Product descriptions in this webshop are based on information supplied by our manufacturers and distributors.

SHIPPING

With our transport partners, we ship to all countries. We are experienced in dealing with orders from all over the world. Generally speaking, if you can send an order to us, we can easily send the shipment to you. Parcels of more than 30 kg or individual items which are too bulky for regular delivery by postal service as well as large total orders will be sent by road carrier or sea or air freight. Arrangments and quotation will be made individually.

For all parcels of less than 30 kg, which are not bulky, we charge a general rate (in Euro, exclusive of VAT) – Please check the table below for shipping costs. These transport costs are exclusive German VAT, import duties and possible custom's clearance charges. Heavy or bulky shipments and express deliveries will be charged individually by quotation.

We need the card number, expiry date and the cardholder's name and address. Shipments can only made to the card holder's address. Credit card companies request the documentation of the cardholder's account address.


• **Payment in advance** by direct bank transfer via our IBAN-account number as stated on the invoice or ProForma invoice (on special arrangement only).
